Use of Chemicals/Pesticides/Herbicides – such materials/compounds that do not pose health hazards for the boarders must be used. In case any boarder falls sick due to inhalation, ingestion or contamination with food articles, the responsibility shall rest with the Firm.

Dispute Settlement Mechanism: Any dispute arising from incomplete and ineffective jobs and other pecuniary obligations from either side shall be amicably settled. In the case of arbitration/adjudication, the jurisdiction shall be limited to Durgapur, only.

Payment Modalities: Jobs carried out in the Hostels shall be duly recorded in the appropriate forms/registers, and deficiencies, if any, shall be recorded by the Wardens/Matrons of the respective Hostels. The Bills raised shall be certified by the Proctor of the College for onward processing by the College Authorities.

Validity of the Work Order: One Calendar year from the date of acceptance by the Company.

Earlier Termination of The Work Order: This work order may be terminated by the College on grounds of deficient services, or for use of harmful compounds that pose health risks to employees, students and hostel boarders, and the College Authorities shall be under no obligations.

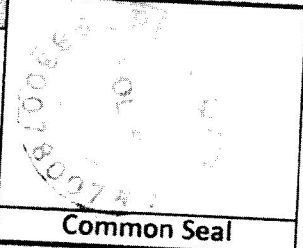
